ATTENDANCE: I (we) agree to attend the Greater Hartford Irish Music Festival (“GHIMF”) at 132 Commerce Street, Glastonbury, Connecticut regardless of weather conditions (this is a rain or shine event) on the following dates and times:

RENTAL SPACE: I (we) agree to be placed in a location designated by the Festival Committee under a tent in the booth size associated to the fee listed in the table below, with two (2) chairs, and one (1) electrical outlet for lighting and electrical use. I (we) hereby acknowledge that electrical use is limited and agree to provide our own Ground Fault Circuit Interrupter to prevent damages related to use of the provided power source. **I (we) agree to pay a \$100 fine if not completely setup and open for business during the festival hours stated in the Attendance section above.**
